

AN INTERVIEW WITH PAUL WILSON

A Healing, in 1978.

Alex: "Paul, will you give us your full name and address?"

Paul: "Paul Wilson, 813 East 28th, Erie, Pennsylvania."

Alex: "Do you give us permission to use this material for publication?"

Paul: "Yes, I do."

Alex: "Would you give us the name of the doctor or doctors who were on your case?"

Paul: "Dr Monnihan and Dr _____." (not clear on tape)

Alex: "They are from where?"

Paul: "They are from Erie Osteopathic Hospital."

Alex: "Now would you tell us all that you remember from the very beginning, in regards to your illness?"

Paul: "Yes. I had the illness with all the vertebra in my fifth lumbar region was severed from my spine due to an accident. (AUG)"

The doctors would not operate, and for about three years, they put it off and finally they said that if they would operate, I would have a 90% chance of being in a wheelchair. So they gave me pills and everything. And they gave me exercises to do and nothing happened. I was at the Seminar last year when Alex was doing the healing. All morning, sitting in the chair, was really aggravating my back. And at the healing, I walked up to be healed. When Alex healed me, spontaneously, the pain left. I was astounded and I told Alex right away: 'well, the pain left. There is no pain.' And I said: 'my legs don't hurt. The back

doesn't hurt.' He said to go back to the doctors and have them check and find out what the story was..

So I went back to the doctors and they checked me out and I have no problem with my back at all. This is one year later and I still have no problem with my back. It was a spontaneous healing. I have no pain. They had said that I would never lift over twenty-five pounds, and I am lifting 100 pound flour bags again."

Alex: "Did they examine your old x-rays with your new x-rays, or how did they learn that you were healed?"

Paul: "They examined my old x-rays and then they looked at the new x-rays and they couldn't believe the x-rays. My back was healed when they didn't even think surgery could do it."

Alex: "Did they ask you what happened? Did you explain anything concerning this?"

Paul: "Yes, I did. I told Dr _____. I said: 'I went to see Alex Tanous.' I said: 'Alex Tanous is a psychic healer and he used energy--he used psychic energy to fuse my back back together again and it was spontaneous.' The doctor just looked at me and smiled like he believed me and understood it, but he wasn't going to tell anybody else."

Alex: "Did he make any remarks? Did he say anything concerning--?"

Paul: "The one thing Dr _____ said is: 'you are a very lucky person. There is somebody up there that loves you.' He knew that the healing came from Alex but he knew that God directed the healing."

Alex: "How about the other doctor that you had seen? Did you

come into contact with him again?"

Paul: "I talked to Dr Monnihan and he just looked at me and said: 'how does it feel to have a new back?' And I said: 'I don't only have a new back but I have a new spirit too.' I have more confidence in my self now, than I did before."

Alex: "What did he say to that?"

Paul: "He said: 'there must have been something to it. I don't know what it is but the look in your eyes is a lot better than the look you had the last time I saw you.'"

Alex: "How about you, now Paul, do you feel well--you have had no problems over the last year?"

Paul: "No problems. For about a month after that, I watched myself, but I also noticed that with the healing; it wasn't just the healing of my back, my spirit, my consciousness, my whole aspect of using the sixth sense and working with psychics was changed. I gained a lot more confidence in myself,--physically, spiritually and mentally."

Alex: "In other words, you were holistically healed?"

Paul: "Right, the whole thing was healed!"

Alex: "Thank you very much, Paul."

CANDY BERGESS DESCRIBES HER HEALING
FOR THE SEMINAR AT
UNIVERSITY OF SOUTHERN MAINE
PORTLAND, MAINE.
June 1, 1979.

My husband and I had a very severe car accident. I had just had surgery on my spine three months before, as a result of the accident. I was the only one hurt and I kept getting worse. I was partially paralyzed from my waist down for awhile and I was almost totally blind for five and one-half months. It was the pressure that did it. I kept having physical problems. It was just one thing after another and I went to one doctor for one thing and another doctor for another thing. I went to all the different specialists and noone ever seemed to put everything together until I found one doctor who found out that I had a tumor on the pituitary gland. During this time some of the problems that I had were that my eyes bothered me terribly, and I couldn't read for over fifteen minutes or watch T.V. for any length of time. Things were so dreary that it nearly drove me crazy. I had severe headaches, and just numerous things.

They told me that there was nothing really, that could be done. The operation was too risky--and it was most likely that I wouldn't make it. And so they gave me a book on "Death and Dying", which I thought was quite--well, really neat--just super!

Then I came to Alex's class and I had been talking to one of my friends. She had been going through the whole thing

with me. I talked to her all the time about it. She was the one who talked to Alex. Her class was just before mine. She met me coming to class and she was just coming out of hers. She said: "I have spoken to Alex about a healing." I said: "well, he is not crippled." or something like that. She did it for me. I was really very nervous about it.

A couple of friends encouraged me and I went up to Alex as he came out in the hallway. I was so excited that he said that he would help me--that he said he would heal me and I said to him: "well, when can we start?" He just hugged me and he said: "I already did."

He told me that in the cases of cancer he had worked on it took about a week. He explained to me that the disease would be pushed to the very end of the whole course of the disease--of the tumor--and that I would be very ill. Well, it happened. I waited a week and it didn't happen in a week but a week and a half later, it did, and I was very very ill. I couldn't get out of bed. I had horrible excruciating pain all through my back and my head. I was really sick. I couldn't walk. My mouth started to become paralyzed. I couldn't get a spoon up to my mouth, and just a lot of different things. I couldn't get out of bed.

My husband called the doctor and he came and said that there was nothing he could do. That was it! He gave me medication for pain, to make me more comfortable. That Wednesday, I was extremely ill and the second day, I was still real bad, but a little bit better, but not so much that it made me feel

real good. And then I started feeling better all the time. I would say almost two weeks after, I still had---my head that had such bad pain straightened out but it was like my muscles were all swollen. My whole back just ached and I went to the doctor. They had taken x-rays and all the different types of tests and they found out that it was there and they had it all documented and now, there was nothing there.

I came back to class and told him about it--that the doctor didn't want to let me go--everytime I started to walk out the door he would call me back. He said: "wait a minute, I want you to----." He was trying to help me to understand that something had happened. He didn't know what but he really didn't know how I was going to handle it, I guess is what I am saying. He kept trying to talk to me about it, but he didn't know what he was talking about. He was just mumbling along and saying: "well, we will find out". But I already knew and I knew that the Lord had used Alex to heal me.

I am going tomorrow again, for another set of x-rays to prove to them again. He called and asked me so I will go again. But it is gone and I feel great. I feel SUPER! One other thing too, I had a lot of weight on me and I lost about thirty pounds in nine weeks. I'm working all time and I feel super.

INTERVIEW ON A HEALING OF NOVEMBER, 1976.

DR ALEX TANOUS AND RAYMOND ST LOUIS

ALEX:

"Please give your name and address."

RAYMOND:

"My name is Raymond St Louis and I live at 35 Gertrude Ave. in Bideford, Maine. This is about my father-in-law and his name is Alfred Naydor and he also lives in Bideford, Maine. In March of 1976, he was diagnosed to have cancer of the lung, cancer of the base of the tongue, progressing into his stomach and also progressing, probably, into his brain. In March of 1976, he was given one year to live by three different doctors. In November of 1976, I requested that Dr Tanous come to see my father-in-law, and see what he could do to try to heal this cancer. He came over in November of 1976, and laid his hands upon my father-in-law. For approximately five days afterward, my father-in-law's condition seemed to have gotten worse. He progressively got weaker until about a week later, he started getting stronger and stronger. He became more energetic, his appetite came back. He wanted to do more. And for the two previous years he had not left the house. He started going out to visit his daughters and going out to the stores. His general health and his mental health was remarkably improved."

"Since March when the diagnose of cancer was given, he was receiving cobalt treatments for three months on, and five weeks off; three months on and five weeks off, and so on. Since the healing, the doctors could see that he had not needed any kind of cobalt treatments because of his improvement. There was no sign of worsening and the doctors did not feel that he needed any more radiation therapy. The doctors also remarked that the remission, or whatever you want to call it, of the cancer is completely contrary to the type of cancer that he had. The maximum of what he should have had was March 1977, and we are

about seven months beyond that date now. The doctors have no answer for it."

ALEX:

"So the improvement is still the same?"

RAYMOND:

"Yes, the improvement is still the same. As a matter of fact, he went out Christmas shopping a couple weeks ago."

ALEX:

"Now would you say that: 'I give permission for the publication of this case.'?"

RAYMOND:

"Yes. I have asked Mr Naydor and his wife, for permission and they said that they would grant permission for publication."

ALEX:

"And you also --?"

RAYMOND:

"And I also do."

ALEX:

"This is additional information concerning the cancer patient."

RAYMOND:

"I want to mention that the cancer was diagnosed as completely incurable and the cobalt treatments were only to buy time and there was no way that this cancer could be cured as far as the doctors were concerned."

ALEX:

"You also said that they opened him up and closed him up."

RAYMOND:

"They opereated on him and saw what was in there and sewed him right back up again and did nothing else to him."

ALEX:

"Very good. Thank you."
